Government Run by currency of Nation**

**WHEREAS:** As the propose of additional thousand and other currency denomination of Nation, the Gutierrezcracy Government and administration and his republic act propose to be the administrative government or governance administration and law to be the in-charge governance and law of administering the rights of additional thousand denomination and other currency denomination propose in Nation includes the existing approve and use currency denomination to be a new sources of governance or government and administration and as a new projects and services and development to support our currency administrative to the society, government and nation.

**WHEREAS:** the Gutierrez-cracy is a name propose to be the symbol of respect and honor of familyname of propose bearer of One Million (Isang Milyon) piso, Jorge Marlo Mira GUTIERREZ as the administration (administrative) project and services offered and promote to the society and government.

**Article I**

**Section I: Title: This Act shall be known as the “Universal Government” and The “Government that Run by Power, Control and rights of Money and Belief and bearer of Money of Nation” and to be known as the “World Government of Money” /National Administrative/Governance of Currency of Nation.**

**Section 2: Declaration of Policy and Principle**

- I. To declare and/that there shall be “Universal Government” and “Government that Run by Power, Control and rights of Money and Belief and bearer of Money of Nation” and to be the “World Government of Money” /National Administrative/Governance of Currency of Nation under and bear by Gutierrezcracy Government.
- II. To declare the **GUTIERREZCRACY GOVERNMENT** as a Universal Government or Universal form or Type of Government that under by the rights of Kontrolerism Society and Government of Nation’s.

- III. To declare the **GUTIERREZCRACY GOVERNMENT** as a social political system of Government and a form or type of Government which is semi aristocracy, monarchy and kleptocracy where people run by the power of money and wealth, or by following the belief of money, currency of nations and wealthy people, that under by the rights and control of Kontrolerism Society and Nation's Government and Military.
- IV. To declare that the Gutierrezcracy Government will have the rights and control in Money or Currency of Nation's that under by authorized by the Nation's Government and central banks of Nation's with respect to the belief of Gutierrezcracy Government that shall to be known as the "World Government of Money".
- V. To declare that Currency of the Nation's and his bearer and belief will have the rights and to use and control over people lives and livings as a way of life that under by the authorized, control and rights by the Gutierrezcracy Government.
- VI. For the semi-Aristocracy, Kleptocracy, Monarchy-Gutierrezcracy; is to declare the aristocrats and wealthy families and people of the Nation's to have the rights and authority to control over their own people lives and be follow and obey as the way of life that this people that be assure to live and be given the enough money, income to sustain their needs in their lives and livings and with also respect to Human Rights, that this rights is the rights of personal attachment to this people in term of sexual, physical and psychological etc. that under by authority, Rights and control of Gutierrezcracy Government.
- VII. To Declare the **Gutierrezcracy Government** as National Administrative/Governance of Currency of the Nation/Philippine.
- VIII. To propose and/or promote and uphold the Gutierrezcracy Government and administration as one of form and type of Government and administration as an form and type of Government and administration that run by currency and/or money of nation or by following the currency of nation and his belief in nation in each nations/countries in the world. (e.g. Gutierrezcracy Government and administration in USA, Russia, China etc.)

### Section 3: Definition of Terms

- a. **"Nation"** Shall means as the Office of the President and the Legislative Branch of the Nation, Government.
- b. **"Government"** Shall mean as the Executive Branch of the Nation, Government.
- c. **"Religion"** Shall mean as the Religions of the Philippine and in the world.

- d. **“Society”** Shall mean as the people and citizen of the Nation’s, Society, Organization and groups of people of Nation’s.
- e. **“Military”** Shall mean as the Arm Forces of the Philippine, Arm Forces of Nations, This is the Nations Police, Army, Navy, Air Force and Intelligence.
- f. **“Gutierrezcracy Government”** shall mean as the Universal Government or Universal Type of Government and is a form or type of Government which is semi aristocracy, monarchy and kleptocracy where people run by the power of money and wealth, or by following the belief of money of nations and wealthy people.
- g. **Kontrolerism Society”** shall mean a "Nation and State society of the Philippine and World State and Nation Society in the World and the New Generation Society and One World Society and Universal Society and a way of life of anyone and allname.
- h. **“Kontrolerism”** shall mean as the unity of Gods and Society of Gods and group of people that has the highest position in the Nation, Government, Military, Religion and Society.
- i. **“Kontroler”** Shall mean as the official alias of the member of Kontrolerism society and an alias of people that has the position in the Nation, Government, Military, Religion and Society.

## **Article II**

### **Section 4: Construction Purpose**

To have a Government and Society and Community that center on rights and importance and value on money in people life and livings and to help the needs and support the people’s in their financial when it comes to knowledge and services and to have a ONE WORLD GOVERNMENT OF MONEY in the World.

## **Article III**

### **BOARD OF OFFICIALS**

#### **Section 5: Board of Officials**

The Board Officials of Gutierrezcracy Government compose of Honorary Chairperson and President, Chairperson and President, Vice President.

#### **Section 6: Honorary Chairperson and President**

The Gutierrezcracy Government allows and recognize to have his honorary Chairperson and President as the Honorary Chairperson and President of Government run by currency of Nation which is under by the

name of Jorge Marlo Mira Gutierrez in respect and honor as proposer of foundation of Gutierrezcracy Government and its development.

## **Article IV**

### **Section 7: Acts to the Gutierrezcracy Government**

1. Protects the public interest of the People.
2. To give a priority to education, science and technology, arts, culture and sports for poster patriotism and nationalism or internationalism World and Worldwide accelerate social progress and promote total human liberation and development.
3. To Protect the Rights of the people.
4. To recognized the sanctity of members' family life and shall protect and strengthen the member's family as a basic autonomous social institution.
5. To values the dignity of every members and people and guarantees the full respect for human rights.
6. represents, advances, and defends the interests of the independent legal Profession of individual.

### **Section 8: Acts of Violence to the Gutierrezcracy Government Kontrollerism Society**

1. **Psychological Violence** - Psychological violence occurs when someone uses threats and causes fear in an individual to gain
2. **Physical Violence** - Physical violence occurs when someone uses a part of their body or an object to control a person's actions.
3. **Sexual Violence** - Sexual violence occurs when a person is forced to unwillingly take part in sexual activity.
4. **Financial Abuse** - Financial abuse occurs when someone controls a person's financial resources without the person's consent or misuses those resources.

### **Section 9: Law and Rules**

1. The Law and Rules of Gutierrezcracy Government is the existing law and rules of money of our Nation to the society. That may apply to the Gutierrezcracy Government and its people that committed violence of this law.
2. The Law and Rules of Gutierrezcracy Government is the law of the following:

- a. **Imperative Law** - means a rule of action imposed upon mere by some authority which enforces obedience to it." In their words it is a command enforced by some superior power either physically or in any other form of compulsion.
  - i. **Divine laws** are consists of the commands imposed by God upon men either by threats of punishments or by hope of his blessings.
  - ii. **Human laws** are the laws by analogy.
- b. **Physical or Scientific Law**
- c. **Conventional Law** - It is the body of rules agreed upon- and followed by the concerned parties to regulate their mutual conduct. It is a form of special law and law for the parties which can be made valid or enforced through an agreement.
- d. **International Law** - is the body of principles and rules which civilized states consider as binding upon them in their mutual relations." It can be defined as "the name for the body of customary and conventional rules, which are considered legally binding by civilized states in their intercourse with each other.
  - i. **Public International Law:** It prevails universally in all over the world.
  - ii. **Private International Law:** It is enforced only between some of states.
- e. **The Law and Rules of Money or the Law and Rules of God of Money of Kontrolerism Society.**

#### **Section 10: People Rights – This is the Human Rights of Gutierrezcracy Government.**

1. The Gutierrezcracy Government people values the dignity of every people's and guarantees the full respect for human rights.
2. Gutierrezcracy Government people shall cooperate to the Nation Laws and Rules of HUMAN RIGHTS.
3. Investigate, on its own or on complaint by any party, all forms of human rights violations involving civil and political rights.
4. Grant immunity from prosecution to any person whose testimony or whose possession of documents or other evidence is necessary or convenient to determine the truth in any investigation conducted by it or under its authority.
5. Gutierrezcracy Government people may provide for other cases of violations of human rights that should fall within the authority of the Commission, taking into account its recommendations.

## **Section 11: Government Rights**

1. Government Shall cooperate to the Nation Laws and Rules of HUMAN RIGHTS
2. Provide for other cases of violations of human rights that should fall within the authority of the Commission, taking into account its recommendations.
3. Monitor the Gutierrezcracy Government peoples and its Organization compliance with international treaty obligations on human rights.
4. Investigate, on its own or on complaint by any party, all forms of human rights violations involving civil and political rights.
5. Adopt its operational guidelines and rules of procedure, and cite for contempt for violations thereof in accordance with the Rules of Court.
6. Appoint its officers and employees in accordance with law; and Perform such other duties and functions as may be provided by law

## **Section 12: Religion Rights – This is the Rights of the Religion to the Gutierrezcracy Government.**

1. Religion shall cooperate to the Nation Laws and Rules of HUMAN RIGHTS.
2. **Rights of Religion to be an agent of socialization and social control** – the Rights of religion as one of the most important agents of socialization and social control. It has significant role in organizing and directing social life. It helps in preserving social norms and strengthening social control. It socializes him individual and exercises control over both individual and group in various ways. As an informal means, religion regulates the activities of people in its own way.
3. **Rights of Religion to promote welfare** - Religion has the rights to teaches to the people to serve the masses and promote their welfare. It gives message that "the service to humanity is service to God". For this reason, people spend money to feed poor and needy. Great religions like Hinduism, Islam, and Christianity etc.
4. **Rights of the Religion to gives recreation** – the Rights of Religion to plays a charming role in providing recreation to the people. Religious rites and festivals are more or less performed in every religion which gives relief to the people from mental exertion.
5. **The Rights of Religion to influence economy**
6. **Rights of Religious to influence political system**
7. **The Rights of the Religion to converts the animal qualities to human qualities** – Rights of the Religion to inculcate the spirit of self-service. It demands that people should be charitable and benevolent. Through various religious experiences the people forgets the worldly life and

problems. This experience suppresses the animal desires and converts the animal qualities of man to human qualities.

## **Article V**

### **Gutierrezcracy Form and Types of Government**

**Section 13:** The Gutierrezcracy Form and Types of Government shall be known as the Form and Types of Gutierrezcracy Government Use by the Nation's Government, This is the Form and Type of Government that run by power and right of Money. This are the Following:

**Section 14:** In Behalf of the Kontrolerism Society and Gutierrezcracy Government I Jorge Marlo Mira Gutierrez founder of Gutierrezcracy Government I hereby propose the Form and types of Gutierrezcracy Government to be use and be include in this Republic Act. This Form and Types of Government as follows:

**Section 15: Title: The "Democracy-Gutierrezcracy Government"** Shall be known as the one form or type of Gutierrezcracy Government where people has the power, control and rights of Money of Nation's, Government.

**Section 16: Title: The "Republic-Gutierrezcracy Government"** Shall be known as the one form or type of Gutierrezcracy Government where Authority and Government Officials has the power, control and rights of Money of Nation's, Government and people.

**Section 17: Title: The "Monarchy-Gutierrezcracy Government"** Shall be known as the one form or type of Gutierrezcracy Government where Royal Families has the power, control and rights of Money of Nation's, Government and people.

**Section 18: Title: The "Gutierrezcrats-Gutierrezcracy Government"** Shall be known as the one form or type of Gutierrezcracy Government where bearer of Money or currency of Nation, wealthy people has the power, control and rights of Money of Nation's, Government and people.

**Section 19: Title: The "Aristocrats-Gutierrezcracy Government"** Shall be known as the one form or type of Gutierrezcracy Government where noble family, wealthy people has the power, control and rights of Money of Nation's, Government and people.

**Section 20: Title: The "Federal-Gutierrezcracy Government"** Shall be known as the one form or type of Gutierrezcracy Government where the power, control and rights of Money of Nation's, Government and people is divided in authority under in one central authority.



## **Article VI**

### **Governance**

#### **Creating of Bureau of Currency**

##### **Section 21**

###### **Title**

The bureau of Currency shall be known as the administrative department attached to the department of Bangko Sentral ng Pilipinas (BSP) in charge of handling and governing the currency of Nation, more important of additional currency denomination and Gutierrezcracy Government and administration.

##### **Section 22**

###### **Declaration of Policy**

1. To Declare and promote and/or there shall be a Bureau of Currency as the administrative department attached to the department of Bangko Sentral ng Pilipinas (BSP) in charge of handling and governing the currency of Nation, more important of additional currency denomination and/or under by Gutierrezcracy Government and administration.
2. To Declare the Bureau of Currency to be the in-charge of administering and printing the additional denomination Banknotes of Nation.
3. To Declare the Bureau of Currency to be the central administrative office in-charge of banknotes governance of Nation under by new promote Banknote Government System (BGS) that under in control and/or in respect in services of Gutierrezcracy Government and administration.
4. To promote the establishment of Bureau of Currency as an administrative department attached to central bank of each nations that administer the additional thousand banknotes propose in each nation's, under by Gutierrezcracy Government law propose in each nations/countries in the world.
5. Other as may provided by law.

##### **Section 23**

###### **Function of Bureau of Currency**

1. To administer and printing the additional denomination Banknotes of Nation
2. To supervise the governance of currency of Nation under by new promote Banknote Government system.
3. To be the central administrative of Gutierrezcracy Government and administration
4. Other as may provided by law.

## **Section 24**

### **Governing Officials**

Bureau of Currency Governing Officials shall compose of three (3) Board officials compose of:

- (1) Chairman of Board of Bureau of Currency
- (2) President of Gutierrezcracy Government and administration and
- (3) Deputy Governor of Bangko Sentral ng Pilipinas

And President of Bureau of Currency and Directors.

## **Section 25**

### **Functions of Governing Officials**

- i. Is to promote and govern and administering the Bureau of Currency and his services and development.
- ii. Other as may provided by law.

## **Creating of Bureau of Currency Branches**

## **Section 26**

### **Declaration of Policy**

1. To Declare and promote and/or there shall be a Bureau of Currency branches as in-charge of administrative services and its development of Bureau of Currency Office.

#### **The bureau of Currency branches shall compose of the following;**

- (1) Currency Supervision
  - (2) Currency Administrative Office
  - (3) Management
  - (4) Security
  - (5) Gutierrez Monetary Plant Complex
  - (6) Bank (Worldwide Bank Organization)
2. Other as may provided by law.

## **Section 27**

### **Functions of BOC Branches**

#### **1. Currency Supervision Branch**

A BOC branch in-charge on supervision and administrative services of Currency Banknotes and coin denomination.

## **Currency Supervision Branch under offices:**

### **i. Currency Denomination Administrative Offices**

A under branch of Currency Supervision in-charge of handling each currency banknotes and coin administrative and services to the government and society., Currency Denomination administrative Offices is a offices of each registered currency denomination that has its own services and function to the government and society, it also in-charge of documents and papers works of currency denomination administrative offices.

#### **Currency Denomination administrative offices are follows;**

- a. One (1) Currency (Piso) Denomination Office, An administrative office in-charge of One (1) Currency (Piso) coin denomination services.
- b. Two (2) Currency (Piso) Denomination Office, An administrative office in-charge of Two (2) Currency (Piso) coin denomination services.
- c. Five (5) Currency (Piso) Denomination Office, An administrative office in-charge of Five (5) Currency (Piso) coin denomination services.
- d. Ten (10) Currency (Piso) Denomination Office, An administrative office in-charge of Ten (10) Currency (Piso) coin denomination services.
- e. Twenty (20) Currency (Piso) Denomination Office, An administrative office in-charge of Twenty (20) Currency (Piso) banknote denomination services.
- f. Fifty (50) Currency (Piso) Denomination Office, An administrative office in-charge of Fifty (50) Currency (Piso) Banknote denomination services.
- g. One Hundred (100) Currency (Piso) Denomination Office, An administrative office in-charge of One Hundred (100) Currency (Piso) banknote denomination services.
- h. Two Hundred (200) Currency (Piso) Denomination Office, An administrative office in-charge of Two Hundred (200) Currency (Piso) banknote denomination services.
- i. Five (500) Currency (Piso) Denomination Office, An administrative office in-charge of Five (500) Currency (Piso) banknote denomination services.
- j. One Thousand (1000) Currency (Piso) Denomination Office, An administrative office in-charge of One Thousand (1000) Currency (Piso) banknote denomination services.
- k. Other Additional Thousand currency Denomination Offices, An Administrative Office of additional thousand currency (Piso) Banknotes services.

### **ii. Currency Denomination Management Office**

A under branch of Currency Supervision in-charge of management of currency denomination services and projects.

### **Currency Denomination Management Offices is;**

- a. Currency Denomination Project and services Department, a Department in-charge and manage all the projects and services of Currency Banknotes and Coins Denomination Offices.

## **2. Currency Administrative Office**

A BOC Branch that authorize and permitted by Bangko Sentral ng Pilipinas aslo in-charge of administration or administer of Currency, includes printing and issuance of Currency, mostly and especially the additional banknotes denomination,

Currency Administrative Office is authorize by Bangko Sentral ng Pilipinas to administer to issue and print banknotes under by Gutierrez Monetary plant Complex of BOC.

Currency Administrative Offices services is divided into his under branch departments are of following:

### **i. Currency Issuance Department**

A Department of Currency Administrative Office that in-charge of issuance of Bureau of Currency own print banknotes and money to the nation.

#### **Functions;**

- a. Approved and issue of banknotes that under by bureau of currency issue
- b. Other as may provided by law.

### **ii. Currency Printing Department**

A Department of Currency administrative Office that in-charge of printing of Bureau of Currency own banknotes and money to the nation.

#### **Functions;**

- a. Approved of printing banknotes under by Bureau of Currency Printing
- b. Other as may provided by law.

### **iii. Currency Administrative**

A Department of Currency Administrative as serve as the head office of Currency administrative.

**Functions;**

- a. Approve the issue and printing of banknotes of Bureau of currency.
- b. Other as may provided by law.

**3. Management**

A BOC branch in-charge of overall management of the Bureau of Currency,

**Functions;**

- a. Approve all the projects and services of BOC, includes finance, auditing and budgeting.
- b. Other as may provided by law.

**Manage under branches and offices;**

**i. Finance Department**

A department of Management that approved and documents all the finances of projects and services of BOC.

**ii. Budget Department**

A department of Management that approved and documents and budgets all of the projects and services of BOC.

**iii. Audit Department**

A department of Management that approved and documents and audit of the projects and services of BOC.

**iv. Project Department**

A Department of Management that approved and documents all the projects and services of BOC.

**4. Security**

A branch of BOC in-charge of all securities and protection of BOC.

**Functions;**

- a. Secure banknotes, employee and workers, projects and services and laws, rights and own physical forces like its own military police policies securities.
- b. Other as may provided by law.

**Security branches Department;**

**i. Currency banknotes Department**

A security department in-charge on securities of banknotes and currencies, money.

**Functions;**

- a. Check and validated and examine the banknotes and money before and after printed if it is ready and secured.
- b. Other as may provided by law.

**ii. Counterfeiting**

A security department in-charge on counterfeiting problems of banknotes and money.

**iii. Intelligence Department**

A Security Department in-charge on intelligence services of BOC.

**iv. Research Department**

A Security Department in-charge on research services of BOC.

**v. Currency Military Police Department**

A Security Department in-charge on Military Police securities and services of BOC.

**vi. Medical Department**

A Security Department in-charge of medical and health of employee and workers of BOC.

**vii. Other as may provided by law.**

**5. Gutierrez Monetary Plant Complex**

A branch of BOC that in-charge of Printing Money, Gutierrez Monetary Plant Complex is the other plant complex that authorize and permitted by Bangko Sentral ng Pilipinas to Print Money. Gutierrez Monetary Plant Complex print banknotes for the capacity and limited pieces that authorize and permitted by Bangko Sentral ng Pilipinas (BSP).

## **BANK**

### **Worldwide Bank Organization**

#### **Section 28**

##### **Declaration of Policy**

1. To Declare and promote and/or there shall be a BANK branch as own-control Bank Organization of Bureau of Currency, under in the name of Worldwide Bank Organization or WWBO
2. To Declare the Worldwide Bank Organization as the Bank Organizations of register members banks and/or that permitted and authorized to accept, circulate or use the additional thousand banknotes.
3. To promote the worldwide bank organization or WWBO to be the international worldwide bank Organization under by propose bureau of Currency, bank branch of every nations in the world.
4. Other as may provided by law.

#### **Section 29**

##### **Governing Officials**

Worldwide Bank Organization Governing Officials shall compose of Chairman, which is the Chairman of Board of BOC, President and Directors.

#### **Section 30**

##### **Functions of WWBO**

1. Serve as the worldwide banks organizations and group of register member bank and user of additional thousand banknotes of Nation.
2. Serve as the governance, control and maintain the proper cooperation of using, circulating the additional thousand banknotes under in Bank to banks transactions.
3. To promote bank to banks transaction regulations of additional thousand banknotes.
4. Other as may provided by law.

## **Article VII**

### **Final Provisions**

#### **Section 31: Rules and Regulation**

Upon The approval of this Act in within Six (6) Months The Department of Interior and Local Government (DILG), Bangko Sentral ng Pilipinas (BSP), Anti – Money Laundering Council (AMLC), Bureau

of Treasury, Land Bank, Development Bank of the Philippine (DBP), Department of Finance (DOF), Department of Budget and Management (DBM), Bureau of Internal Revenue (BIR), Commission on Audit, Department of Trade and Industry (DTI), Office of the Senate, House of Representative, Office of the Vice President, Arm Forces of the Philippine (AFP), Department of Justice (DOJ) and Supreme Court shall submit and promulgate the implementing Rules and Regulation (IRR) of this act.

**Section 32: Funding**

The Funding and necessary amount to implement the provision of this act shall be get from the Government Funds issued from the Department of Finance (DOF).

**Section 33: Suppletory Application or Appropriations**

The purposes of this Act, the Revised Penal Code and other applicable laws, shall have suppletory application.

**Section 34: Separability Clause**

If any Sec. or provision of this Act is held unconstitutional or invalid, the other Sec.s or provisions shall not be affected.

**Section 35: Amendments or Revision**

Any amendments to, or revision of this act may be propose by Any appointed officials of Gutierrezcracy Government that approved and authorized by Chairperson and President and honorary Chairperson and President.

**Section 36: Repealing Clause:**

That All laws, Presidential decrees, executive orders and rules and regulations, or parts thereof, inconsistent with the provisions of this Act are hereby repealed or modified accordingly.

**Section 37: Effectively Clause:**

This Act shall be effective fifteen (15) days from the date of its publication in Official Gazette or in at least two (2) newspapers of general circulation.
